RULES AND REGULATIONS

9-6-2008

CHECK-IN AND WAIVERS

All players, coaches, instructors and other participants MUST sign in at the desk prior to entering the practice/instructional area.

ALL persons that enter or participate in any activity in or upon any training area must first have submitted a signed waiver form. By entering the Facility, each team's representative hereby certifies that all players and coaches have submitted a signed waiver form and assumes full responsibility for any such failure. Teams must have their own coach/parent/volunteer(s) present at all times who is/are responsible for the supervision and activity of the team and members.

The facility has no responsibility whatsoever for any personal belongings that are damaged, lost, disappear or may be stolen from the facility premises.

Any person injured at the facility must file a report at the front desk prior to leaving the facility.

The management of the Facility will periodically photograph activities at the Facility that may result in photographs of patrons later appearing in promotional materials or on its website. Use of the Facility constitutes consent to being photographed at the Facility and also consent to the subsequent use of that image by FAST/Wizards.

FAST/Wizards may be utilizing security cameras on-site which may record video and audio of patrons of the facility. By entering the facility you are consenting to being videotaped while in the facility.

Spectators (as opposed to players and coaches that have submitted a signed waiver form to FAST/Wizards facility) are not permitted in the training areas.

FEES

All fees paid to the Fast/Wizards facility are non-refundable. All fees must be current and paid before players and coaches may use the facility. Cancellations due to weather are at the sole discretion of the facility as are any resulting make-up dates. Make-up dates due to cancellations from weather or other unavoidable causes are not guaranteed.

SCHEDULES

The FAST/Wizards facility is a scheduled facility. Please do not enter your prescribed area until your scheduled start time. Teams using the Facility must cease all softball activities at least five (5) minutes before their scheduled finish time to clean up equipment and return the prescribed area to its original state. This includes, but is not limited to, placing all balls back into their respective hoppers/buckets, returning protective screens to their proper place, clean up and dispose of any trash in their practice area, and raking the dirt infield.

PARKING

The parking lot at the FAST/Wizards facility may not be utilized for anything other than parking vehicles (i.e. no ball playing, skateboarding, warm-ups, etc.). Any person violating this regulation shall be subject to immediate expulsion and shall be personally liable for any damage caused to any person or property.

FOOD, DRINK, TOBACCO, ALCOHOL

Gum and tobacco products of any kind and seeds are not permitted in the training area of the facility. FAST/Wizards is an alcohol and a smoke free facility. No alcoholic beverages, cigarettes or tobacco products are allowed. The following items are prohibited: coolers, Firearms, pets, food or drinks of any type, (other than drinks contained in sports bottles for use by a participant, or for birthday parties and/or a special occasion as approved by FAST/Wizards).

HITTING/PITCHING TUNNELS

All players in batting cages and hitting instructional areas must wear helmets at all times. Anyone entering the batting cages must wear an approved helmet. Anyone throwing batting practice and/or pitching to batters must situate themselves behind a protective screen. All hitting must be done on a rubber hitting mat, all pitching must be done on a rubber pitching mat. Please do not use the grass area to hit or pitch.

A maximum of two people are allowed in any batting station at any time. These two people are: (a) a batter wearing a helmet; and (b) a pitcher throwing behind a protective screen.

Additional batting tunnel rules are attached.

EQUIPMENT/CLOTHING

Players, coaches and all other team representatives must leave their equipment in their designated training area. No equipment is to be left in any other area. Equipment placed in the lobby and/or walkways/corridors will be moved to the training area by the FAST/Wizards facility representatives. The FAST/Wizards facility will have no responsibility for any lost, misplaced, or stolen items or equipment.

Sneakers and turf shoes are the only footwear items allowed in the training area. No metal cleats are allowed except on the dirt infield. Each person violating this rule shall be responsible for all resultant damages.

BEHAVIOR

Spectators (as opposed to players and coaches that have submitted a signed waiver form) are not permitted in the training areas. Return any found items to the front desk. Place all trash in the receptacles provided for this purpose.

Altercations of any type (physical or verbal) shall not be permitted on the premises (inside or outside), including, but not limited to, between participants, coaches, friends, family members, visitors, etc. or with representatives or employees of FAST/Wizards. The use of profanity by ANY person entering the facility will not be tolerated. No spitting is permitted within the indoor portion of the Facility.

Any individual or organization caught stealing, defacing, defaming or destroying the property of the facility or the property of any other individual or organization is subject to immediate removal and banishment from the Facility. Any person causing damage to the Facility shall be held accountable to reimburse the FAST/Wizards facility, in full, for all repair and/or replacement expenses arising from such conduct prior to subsequent participation at the Facility.

No running, or throwing or kicking of any balls, Frisbees, or any other objects, etc., is permitted in any of the interior areas of the facility other than on the field or in the batting cages. No person (whether or not participating in an activity) may pull, hang onto or harm any of the netting surrounding the fields or tunnels.

Coaches/parents are responsible for the behavior and conduct of all minors accompanying them to FAST/Wizards, whether such responsibility relates to participants who are on their team and/or their own children.

Anyone participating in any training activity releases the FAST/Wizards organization from any and all liability that results from their actions, use of the equipment or the actions of any other person in the batting cage.

VIOLATIONS OF THE RULES OF CONTACT BY ANY INDIVIDUAL MAY SUBJECT THEM TO REMOVAL FROM THE FACILITY. REPEATED VIOLATIONS OF THE RULES OF CONDUCT BY ANY ONE INDIVIDUAL OR ORGANIZATION MAY RESULT IN THE INDIVIDUAL OR THE ORGANIZATION WHICH THE INDIVIDUAL IS A MEMBER, BEING BANNED FROM THE FACILITY AND RESULT IN DEFAULT OF THE FACILITY RENTAL AGREEMENT.
